

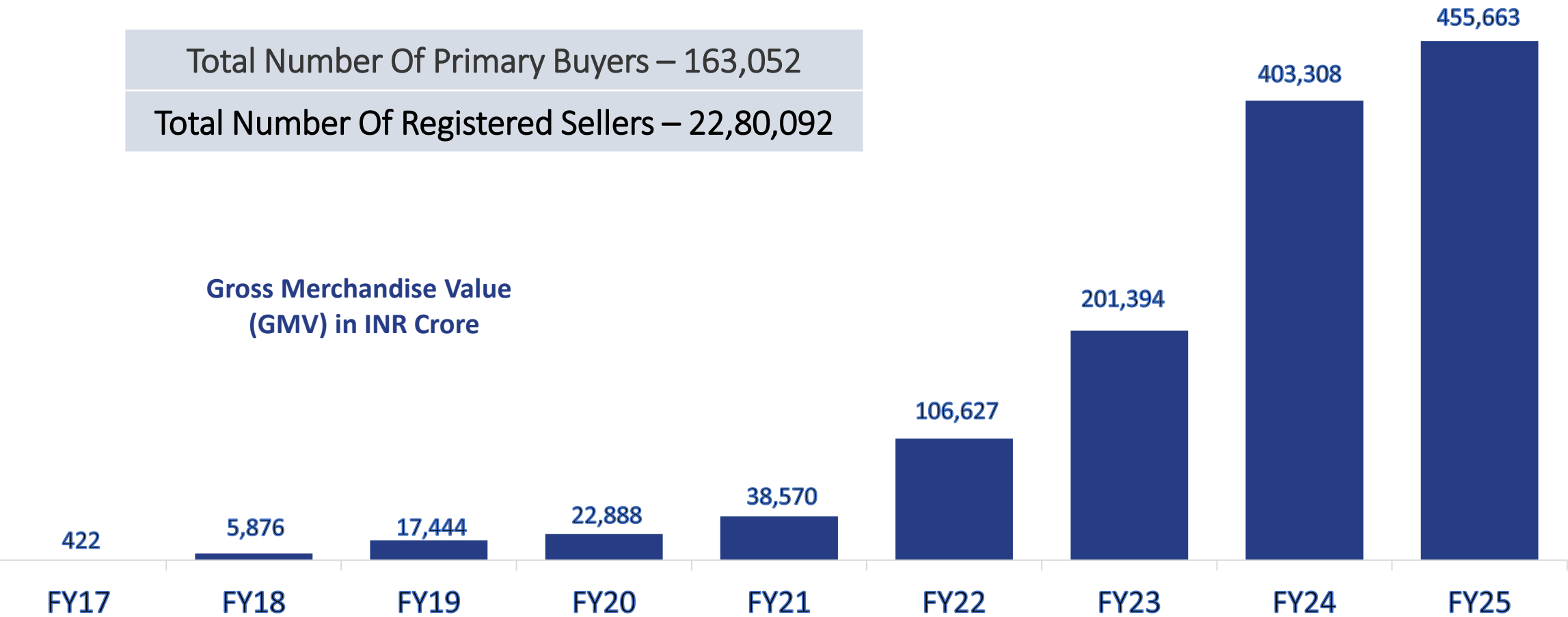

Business overview | Exemplary GMV growth over the years...

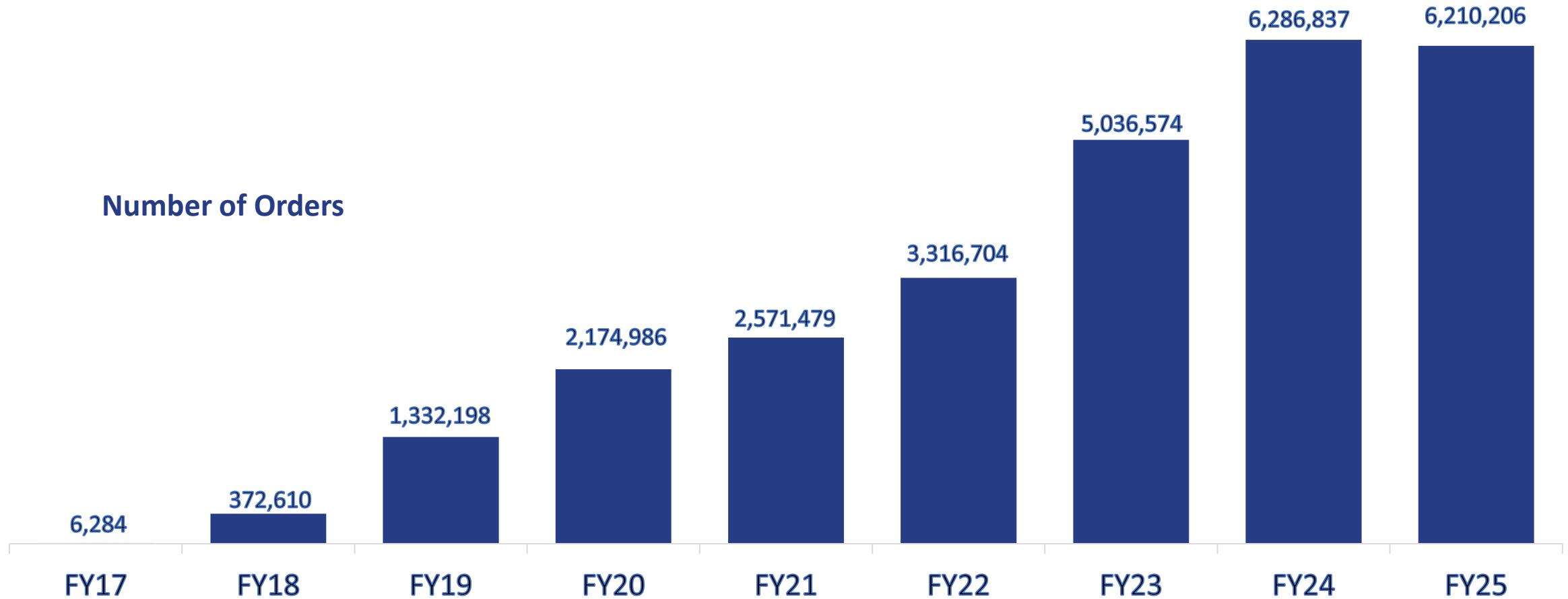
Total Number Of Primary Buyers – 163,052

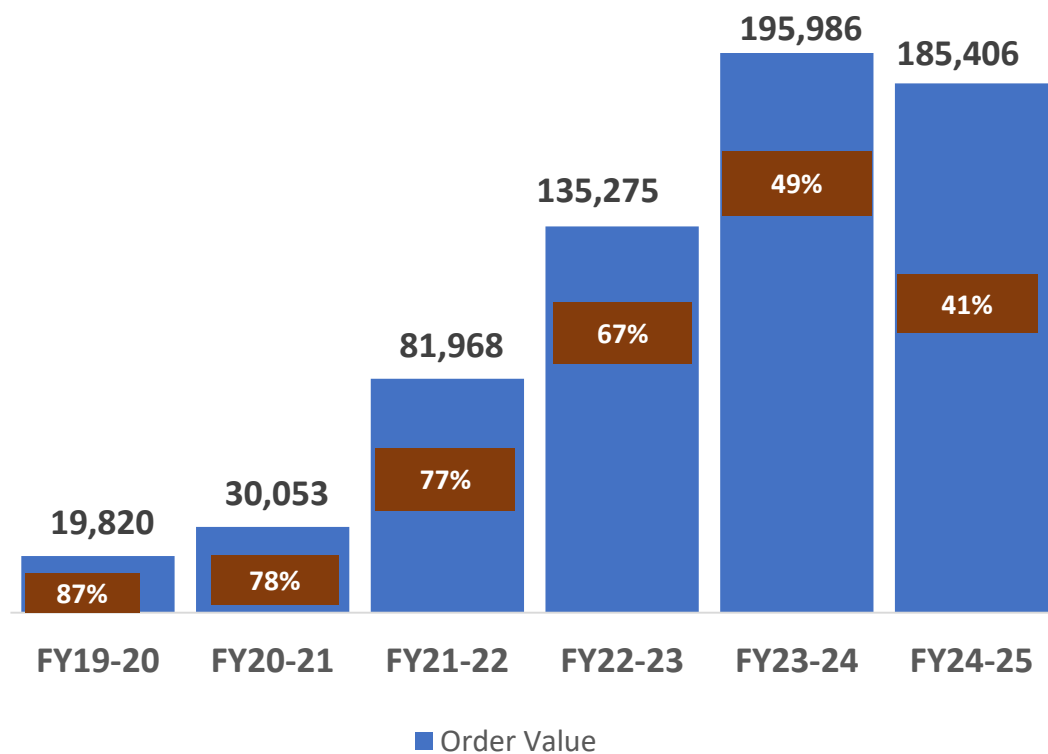

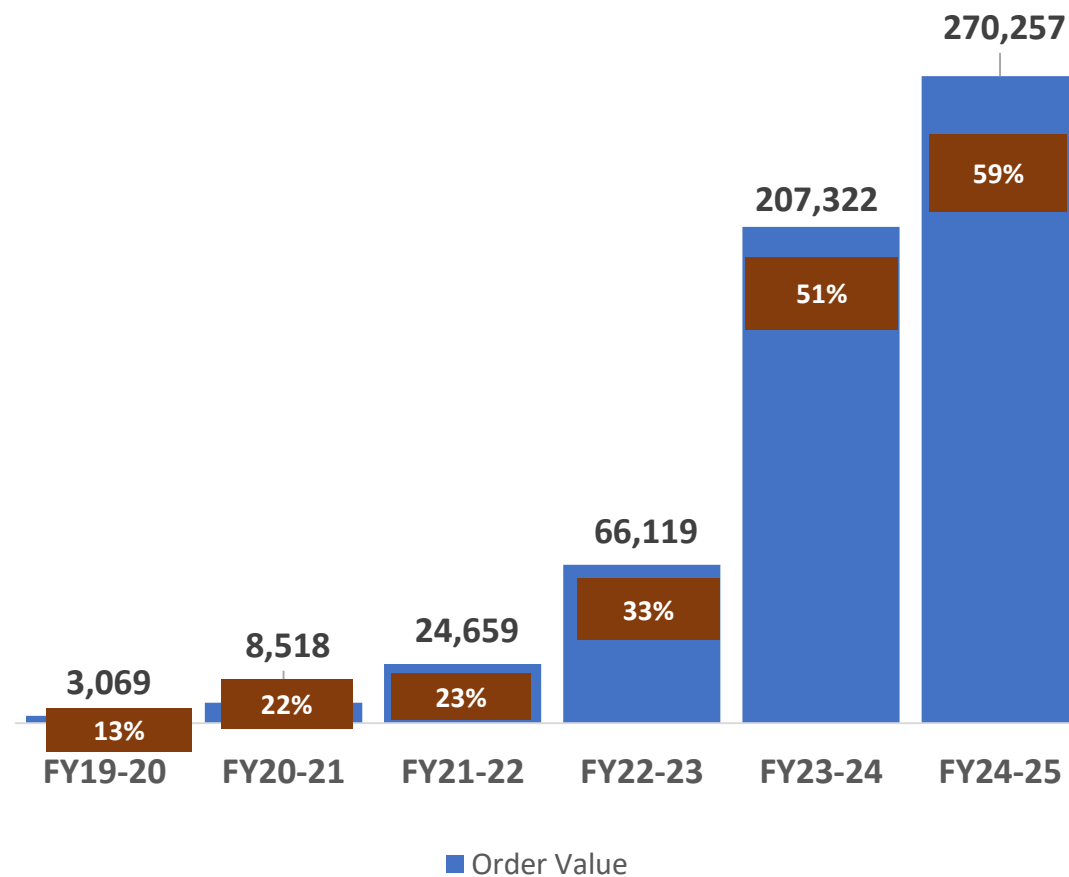

Vendor Assessment

Vendor assessment is done to verify the credentials of GeM sellers

It validates the vendor profile and business profile, including manufacturing capability

Vendor assessment is done by RITES and is paid for by vendors

GeM also allows relaxation from vendor assessment based on the following criteria such as:

- Sellers having a turnover of Rs.500 Crore or more
- BIS License holding manufacturers for their registered categories
- Central/State PSUs, Central and State Government Departments/ Authorities etc.

E-Procurement | Bid Evaluation Methods

- **Total Value wise:** L1 will be determined by the **overall cost of the items**
- **Item wise-Schedule wise:** Seller has the choice to participate in a single or multiple items and then after L1 will be determined for **individual items**.
- **Item wise-Consignee wise:** The seller has the option to offer prices for an item at different locations. It helps buyers get the best value because some sellers may be more competitive in some consignee locations.
- **Group Wise:** The **buyer** has the choice to **combine items or schedule them in a group**, and then L1 is determined based on the items available in the group.

Transparency on GeM

- Data for all Bids, Reverse Auctions and Contracts made available for public viewing on the Home page
- Representation against biased bids
- Representation against unjust technical disqualification
- Tracking Business opportunity in public procurement at the category level
 - Seller, OEM and Catalog count available for each category
 - Comparison of Order value and Order volume in the current year versus last year
 - List of brands populating the category
- Functionality of capturing the annual procurement potential of all buyers on GeM
 - Buyers can upload their procurement plan for the Financial Year
 - Demarcation for GeMmable vs non-GeMmable procurement



PRC (Provisional Receipt Certificate) | CRAC (Consignee Receipt & Acceptance Certificate)

- Auto generation of PRC after 4 days if consignee does not take any action.
- The consignee can edit or verify within 2 days of system-generated PRC.
- Consignee must accept or reject the goods within 10 days.
- Auto generation of CRAC if consignee does not take any action.
- The consignee can edit or verify within 3 days of system-generated CRAC.
- Provision for raising supplementary invoice by the seller for the rejected/replaced quantity.



Payments

- Payment to be made within 10 days of CRAC ([DOE order 23-01-2020](#))
- Penal Interest Collection for Delayed Payment ([DOE Order 03-07-2020](#))



Features | Recent

- Yield/Load Based bid Evaluation
- Single-packet bidding
- ITC/RCM Implementation in Tendering Process
- Running Contract in some categories.
- Latest Revenue policy cap of Rs 3 lakh as TC, > 10 Lakh but < 10 Cr. 0.30% of the Order value
- Government To CPSE Transaction Charges Exemption



Features | Recent (Contd.)

- Visibility of the bidder's documents to competitors in bid
- Implementation of the rule no 144(xi) related to Beneficiary ownership in registration
- MII/MSE evaluated status in the contract
- AIML based Intervention
 - IP of buyers and Sellers
 - Comment and Rejection reason appropriateness
- Enabling the feature of restriction in participation of CPSE Seller only in Bid
- Moving toward making e-sign/DSC mandatory



Features | Recent (Contd.)

- View Bunch able categories
- Arbitration clause in bid document – whether required or not.
- Bid Transfer from One buyer to Another buyer
- Impact of suspension of seller during the time of award of contract.
- No Negotiation Post RA
- No visibility of number of sellers before bid opening
- Latest provision related to the LD- Max 5%



Features | Recent (Contd.)

- Change Technical evaluation result post publish of Technical evaluation
- Auto CRAC status on the CRAC
- Bill can be processed by buyer or consignee
- Limited Tender Enquiry enabled for CPSE
- Enabling the interest payment on delayed payment- Calculation available in dashboard
- Unworkable functionality made live for Services -Disqualification of L1 bidder in case of unworkable prices quoted in the financial bid.



Features | Recent (Contd.)

- Disqualification of L1 bidder in case of Bid to RA (before start of RA)
- Option during bid creation for CPSE - "Is bid for commercial resale"? If buyer chooses "yes" contract details will be published after 6 months
- RA Auto extension time increased - Auto extension time of RA will be 30 min(from 15 mins) for bids having more than 50 items with total value wise evaluation
- RA time period – Minimum 24 hours after the start of RA
- Select random 10 L1 bidders in single packet bidding for technical evaluation
- On-Spot Vehicle Hiring (integration with UBER) made live for Delhi-NCR based buyers on pilot basis.



Features | In Pipeline

- Hiding the Bidders name before conclusion of the RA
- Partial closure of orders
- Rate contract
- Online EMD in Bid-Already live in FA

Grievance Redressal on GeM

- GeM has developed a comprehensive grievance redressal mechanism, which includes a Helpdesk and Incident Management system.
- Users can raise issues through multiple channels such as call, email, website, chat, and walk-in help desks - Standard resolution time of 16 business hours.
- GeM has put in place a strong automated processes to penalize any deviant behaviour from the terms and conditions of procurement on GeM and relevant Government guidelines.
- On-line mechanism for reporting and initiating action on any such deviation, and defaulting entity face penalties such as suspension, catalogue removal, impact on rating etc.
